1.	220127-ROQ LEGISLATIVE SERVICE PROVIDERS This Contract provides qualified firms who offer state legislative representation as an authorized public lobbyist for the County. Firms assist the County with achieving specific state legislative objectives as identified by the Board of Supervisors and represent the County regarding state legislative matters that do, or may, impact the County. Contractors supplement the efforts of County elected officials, the Government Relations Office and other County employees at the Arizona State Legislature. This Contract contains options for contract renewals and is being renewed for a term of one year, through November 30, 2023. The remaining MA balance in Advantage 3x of \$46,666.67 is not sufficient to cover anticipated spend thru the end of this new term, so \$400,000.00 needs to be added to the Contract award value. 2.	220137-S, NATURAL GAS LOG SET INSTALLATION This Contract provides County residents an opportunity to convert wood burning fireplaces to natural gas and properly install natural gas log sets in county residents' homes which are currently plumbed for natural gas, in support of the Maricopa County Fireplace Retrofit Program (MCFRP). Air Quality uses this contract to connect interested County residents with qualified contractors. This Contract contains options for contract renewals and is being renewed for a term of one year, through November 30, 2023. The remaining MA balance in Advantage 3x of \$69,789.50 is sufficient to cover anticipated spend through the end of this new term, so no additional funding is required. Additional services available to multiple County departments through this contract include fire alarm systems monitoring, testing, inspection, service, and preventative maintenance, full service maintenance for portable fire extinguishers , and firefighter air system testing. This value increase is necessary to support the testing of fire alarm systems and fire suppression devices located at various County facilities. Request Contract value increase of \$775,000 that would change the current award amount from \$1,200,000 to a new award total of \$1,975,000.
