39. INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT WITH THE STATE OF ARIZONA

Approve and authorize the Chairman to execute an Intergovernmental Cooperative Purchasing Agreement with the State of Arizona. This Agreement will take effect upon approval of both parties and shall remain in effect until either party terminates the Agreement.

This Intergovernmental Agreement will facilitate the cooperative procurement of materials and services acquired through the use of contracts procured through the Arizona Department of Administration with the intent of conserving resources, improving cost structures and reducing procurement costs.

This Agreement replaces the existing Agreement approved by the Board of Supervisor under agenda, C-73-18-017-3-00, which expires on November 18, 2022. (C-73-18-017-3-01)

Approve and award a professional design services contract between Maricopa County and BWS Architects in an amount. not to exceed \$1,266,661.00 The purpose of the contract is to provide professional design services for the renovation of the Maricopa County Downtown Court Plaza. The increase in the contract value is due to increased anticipated usage of the contract by the Maricopa County Department of Transportation. No vendor prices increases have been requested.
