PY2019 ANNUAL ACTION PLAN SUBSTANTIAL AMENDMENT 3
REGARDING CARES ACT FUNDING TO RESPOND TO COVID-19

BACKGROUND

U.S. Department of Housing and Urban Development (HUD) provided notification that Maricopa County received a second funding allocation of Community Development Block Grant (CDBG-CV3) as a result of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136. The funds may be used to cover or reimburse allowable costs incurred before the award of funding (including prior to the signing of the CARES Act) to prevent, prepare for, and respond to COVID-19. The funding sources include:

- \$2,922,767 of Community Development Block Grant Coronavirus (CDBG-CV3) funds to be utilized to address the needs of low-and moderate-income persons and the development of partnerships between all levels of government and the private for-profit and nonprofit sectors related to COVID-19 pandemic response.

AMENDMENT TO THE ANNUAL ACTION PLAN (AAP) FY2019-2020

Maricopa County Human Services Department has deemed it necessary to make a Substantial Amendment to its 2019-2020 Annual Action Plan to add CDBG-CV3 as a funding source and to allocate the funding source to activities that address the COVID-19 pandemic. This section specifically identifies the projects/activities that will be funded with CDBG-CV3 to address the specific objectives and eligible activities as allowed by the grant.

The proposed amendment to the 2019 AAP is as follows:

1. Allocate \$2,922,767 in CDBG-CV3 funding to the eligible activities listed on the following page.
